In of power conferred on Director General of Police Rule 12  
of Meghalaya Police & Fund Rules, hereafter to as fund,  
11 will amended by addition of the following Sub

Sub- Rule 11.1:- Where a police personnel remains untraced for a long period of  
after departmental inquiry that is instituted to find out the whereabouts of the said  
missing personnel, if it is found out that it is not a of desertion, on receipt of  
application from next-of-kin of personnel who has missing, the Central  
Police Welfare Board can extend a one time financial assistance not exceeding Rupees  
Twenty five thousand from the Central Police Relief and Welfare Fund depending upon  
financial condition of family. This will however be subject to the condition that in  
case concerned personnel subsequently resurfaces; amount of financial  
assistance will be recovered from him without interest.


